## 5/18/6 Financial statement

Balance carried forward from 2016/17 - £9933

Income & expenditure 2017/18 (see attached Accounting Statements)

Income (precept + other receipts) -£4935 + £6237 = £11,172Expenditure (staff + other payments) -£2346 + £9193 = £11,539

Remaining balance – £9566 carried forward to 2018/19

Of this balance £210 is held on behalf of the Sterndale Moor Defibrillator Project leaving a balance of £9356 as current funds for Parish Council planned Liabilities and future Expenditures.

Assets of the Parish Council are historically valued at £227,072 including the Parish Hall which has now been registered with the Land Registry.
